

New and renaming of categories for disclosure on First North

Nasdaq European Surveillance is pleased to announce the implementation of new and renamed categories which are to be used when disclosing regulatory press releases on Nasdaq First North Markets. These categories are designed to ensure that the information is communicated clearly and effectively, making it easier for the investors and the market to understand the nature and importance of information disclosed.

The new and updated categories for First North will reflect as much as possible with the categories used for the regulated market.

The implementation will take effect from the 25 April 2025 at 18.00 CEST, after which companies admitted to trading on Nasdaq First North Premier Growth Market and First North Growth Market must use the categories when disclosing information to the market.

With the implementation, there will be name changes to some of the categories currently in use. The reason for the name changes is for the categories to better reflect what information is included in a disclosure with reference to a relevant First North disclosure rule.

A category that undergoes a name change will also have effect on historical disclosures in the category being updated to the new name in the regulatory press releases previously disclosed to the market. These announcements will remain accessible in the historical database of previously disclosed regulatory press releases, but with the new name following the implementation.

Categories that are removed

Some existing categories will be removed. This means that certain categories will no longer be available for future disclosures.

Historic disclosures using a category that is removed will still appear with the category in use at the time of disclosure to the market. Therefore, these regulatory press releases will remain available in the historical database of previously disclosed regulatory press releases, retaining the original category designation.
